

## RESOLUTION NO. 09-13

A RESOLUTION ADOPTING THE RECOMMENDATIONS OF THE LEE'S SUMMIT 360° STRATEGIC PLANNING COMMITTEE AS THE LONG TERM STRATEGIC PLAN FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the 21<sup>st</sup> Century Strategic Plans adopted by Resolution 93-12 on November 16, 1993 and updated by Resolution 99-01 on February 4, 1999 have been completed; and,

WHEREAS, the City of Lee's Summit determined the need for citizen input to create a new strategic plan; and,

WHEREAS, members of the *Lee's Summit 360°* Strategic Planning Committee dedicated 8 months to developing a strategic plan for the City; and,

WHEREAS, the Strategic Planning Committee presented a final recommendation to the City Council on August 6, 2009; and,

WHEREAS, the Strategic Planning Committee recommended that the plan serve as both a vision and as a guide for City Council decisions; and,

WHEREAS, the City Council of the City of Lee's Summit wish to express appreciation to all stakeholders who participated in the strategic planning process.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

Section 1. That the City Council hereby adopts the submitted recommendation from the *Lee's Summit 360°* Strategic Planning Committee as the long term strategic plan for the City of Lee's Summit.

Section 2. That the City of Lee's Summit will consider said plan when undertaking actions related to the areas of Education, Economic Development, Health and Human Services, Local Government, Quality of Life, and Transportation in the City.

Section 3. That the City of Lee's Summit accepts the Community Vision Statement developed by the stakeholders as follows:

*Lee's Summit is a sustainable and vibrant city with a dynamic spirit of cooperation among its diverse citizens, businesses, organizations, educational systems and governments. Through comprehensive community planning and regional collaboration, Lee's Summit enjoys economic independence and a high quality of life as a recognized destination city.*
